TENDER NOTICE

Sealed tender are invited from the registered and interested firm/videography related organization for videography work in different districts of Delhi for collection of data related to Mother Tongues Survey of India Project on or before 18th Sept,2012 (up to 2.00 P.M.) through Registered Post/By Hand. The details can be collected from the office on working days.

A: The specifications for Video Recording Equipments:

- 1. HDV Camera with the recording in high definition mode (e.g., Sony Z7 HDV)
- 2. Collar Microphones (e.g., Sennheiser ew 112-p)
- 3. Zoom H4 Audio Recorders
- B: Output of Video Recording and Other descriptions will be as follows:
 - 1. Data for 16 samples of 3 Mother Tongues will be collected within a span of two months starting probably by mid of Sept, 2012 with a requirement of at least 4 Videography teams consisting of one videographer and one assistant for each videography team. The ceiling for videography is Rs.1500/-(fifteen hundred only) per day for the team (one videographer and one assistant) for a maximum period of 10 days for each sample. This includes the cost of three sets of DVDs for each sample to be handed over by the videographer to this office. Each Videography team has to collect 4 numbers of samples from two different mother tongues within 10 days for each sample.
 - 2. For each sample MT, 3 copies of DVDs are to be submitted, one original and two copies.
 - 3. The DVDs are to be handed over by the videographers to this Directorate within 3 days of completion of field work of any sample in the mode prescribe below:

For each sample MT, the DVDs are to be labelled clearly showing the following:

(i)Serial No. of the DVD

(ii) Name of the Mother Tongue along with name of the State/District/Tehsil where it has been recorded.

- (iii) Name and type of informant (e.g. Rama Devi, Rural Female, age 55 years)
- (iv) Name of the sections, subsections, serial number of words/sentences covered in a DVD and the date and time of videography.

The quotation shall be received in the office of the DCO, Delhi on or before 18 Sept, 2012 up to 2.00 p.m. and the same will be opened on the same day at 3 p.m.

Firm may quote their lowest rate within the limit of Rs. 1500/-per day for two persons (one videographer and one assistant) along with the equipments and other costs as stated above. They should specify the number of Teams which should not be less than 4. They need to deposit earnest money of Rs.10000/-in the form of Demand draft in favour of the Director of Census Operations, Delhi, payable at Delhi.

The undersigned, however, reserves the right to select any or reject all the quotations and is not bound to accept the lowest rate. If the tender is accepted, the same will be on satisfaction of the following conditions:

- 1. Completion of the work must be made within the stipulated time, for which requisitions will be sent to successful firm.
- 2. The equipments must be of required quality and if the equipments are not conform to the specified quality, the same will be rejected.
- 3. Transportation, lodging, fooding and cost of DVDs are to be borne by the bidder.
- 4. The bidder/firm will have to arrange sound proof room/studio/accommodation for videography/audio recording.
- 5. The payment will be made only after verification of the work completed by the firm.
- 6. The following items/documents have to be enclosed:
- i) Copy of up to date income tax returns (self attested)
- ii) Copy of sales tax, VAT clearance certificate
- iii) Self certification to the effect that the tenderer is not blacklisted by Central Government.
- 7. Any dispute will be subject to Delhi jurisdiction only.
