### TENDER NOTICE

**Sub: Quotations for disposal of Census Records of Madhya Pradesh and Chhattisgarh 2001 Census - Reg.**

1. Sealed quotations are invited from the tendering of paper/pulp Mills authorized dealers of the pulp Mills having pulping facility for the disposal of approximately 180 to 190 tonnes of 2001 Census records (i) Houselist-Schedules, (ii) House list Abstract, (iii) Household Schedules. (iv) Enumerator's Working Sheets, (v) Enumerator's Abstracts, etc. lying in the Directorate of Census Operations, Madhya Pradesh, Janganana Bhavan, Jail Road, Arera Hills, Bhopal-462004. The successful tenderer will have to lift such records from the Census Directorate, Madhya Pradesh, Bhopal "as is where is basis" and pulp these records in the paper mills in the presence of a Gazetted Officer of the Census Directorate and they have to furnish the certificate to the Directorate of Census Operations, Madhya Pradesh, Bhopal for pulping. These records cannot be used as waste paper for the other purposes.
2. The rate should be quoted per kilogram which would be exclusive of transportation, loading, unloading weight etc., the expenditure on which will be borne by the successful tenderer. The rates accepted will be valid for a period of two months from the date of conveying the approval of the rates by this Directorate. The material will be lifted by the successful tenderer by making full payment in advance within 20 days of communication of the approval. The cost thereof will be adjusted against the said advance money and refund the balance amount, if any after weightment (electronic weigh bridge) in "Dharmakanta".

3. Intending tenderes are to submit their quotations indicating the rate per kilogram accompanied by a Demand Draft of **Rs.25,000/-** (Rupees Twenty Five Thousands only) as earnest money drawn in favour of "**Assistant Director of Census Operations, Madhya Pradesh, Bhopal**" latest by **24th of December, 2009**, which is the **closing date** of accepting the tenders. ***Quotations will be received up to 3.00 pm of the last date and it will be opened at 5.00 pm. on the same day in the presence of authorized representatives of the tenderers who may so desire.*** Quotations should be super scribed as "QUOTATIONS FOR THE DISPOSAL OF CENSUS RECORDS OF MDHYA PRADESH & CHHATTISGARH OF 2001 CENSUS". ***No quotations will be entertained if submitted after the stipulated date / time and incomplete formalities.***
4. The intending tenderers may inspect the records during office hours on any working day with the prior permission of the undersigned.
5. The Director of Census Operations or Joint Director of Census Operations, Madhya Pradesh, however, reserves the right to reject any or all the quotations without assigning any reason thereof.
