CIRCULAR

In pursuance of ORGI letter No. 35018/4/2012-Ad-IV dt. 25.9.2013, it is proposed to fill up the following Group 'C' Posts on deputation/absorption basis amongst the officials of Central/State Government Departments :-

The details of posts and eligibility conditions are indicated in Annexure-I.

The terms and conditions of the candidates selected for appointment on deputation will be governed as laid down in the Government of India, Department of Personnel and Training O.M. No. 6/8/2009-Estt (Pay-II) dated 17.6.2010 as amended from time to time.

The period of deputation will be initially for a period of one year and likely to be continued further. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding to this appointment in the same or other office/department of the Central Government shall ordinarily not to exceed three (3) years. The maximum age limit for appointment by deputation should not exceed 56 years as on the closing date of receipt of application.

The departmental officials in the feeder category who are in the direct line of promotion shall not be eligible for consideration of appointment on deputation. Similarly deputationist shall not be eligible for appointment by promotion

For the purpose of appointment on deputation basis, the services rendered on regular basis by an official prior to 01.01.2006 or the date from which the revised structure based on the 6th CPC has been extended, shall be deemed to be service rendered in the corresponding grade pay/pay scale extended based on the recommendation of the pay commission except where there has been merger of more than one pre-revised scale pay into one grade with a common grade pay/pay scale and where this benefit will extend only for the post of which that grade pay or pay scale is the normal replacement grade without any up gradation.
