## SOMER'S TICKETS - 3 & 4.

### INSTRUCTIONS.

This ticket will be filled up by a team of two people. You will be given two bundles of slips for each taluk one relating to rural areas and another to urban areas numbered serially. Take up the bundle relating to rural areas. Note the name of the district and the taluk in the Sorter's ticket. The slip in the bundle should be tagged together. One man should read out from the slip and another should post them in the relevant columns in this ticket. The livelihood class has been already noted against question 3 in the slip. The total of males and females has been noted at the bottom of the slip. First note the serial number of the slip in column (1) of sorter's ticket. Then the livelihood classes group in the slip should be read out from the answer to question 3 of the slip. Then the total number of males and females noted at the foot of the slip should be read. If it is Livelihood Class I, II or IV note the number of males and females in columns 2 and 3, respectively, of the ticket. If it is Livelihood Class III note the number of males and females in the slip in columns 4 and 5. If it is Livelihood Class V, VI, VII or VIII note the number of males and females in columns 6 and 7. After these entries have been posted read out the age group against which there is an entry in the slip. Say whether it is male or female 'married' or 'others'. The other person should note the number in the column 'married' or 'others' under males or females, as the case may be, in the relevant age group. Similarly post in the Sorter's ticket every entry under 'married' or ~~XXXXXX~~ 'others' among males or females (as the case may be) in the slip. Repeat the process for all the slips relating to rural areas in the taluk. Then take up the slips relating to urban areas and post them in order in the sorter's ticket, as you did in the case of slips relating to rural areas.

NOTE: After filling up each page, the total of every column should be noted at the foot of the Sorter's ticket. Note also the number of entries in each columns from 2 to 7. For purposes of noting the number of slips in each economic group, count the number of entries posted in each economic group and record the figure at the top of the respective economic group -- Columns 2-3 or 4-5 or 6-7, as the case may be. The total for rural areas and urban areas separately in each taluk should be struck.

INSTRUCTIONS.

Number of births in sample households by economic groups and their registration: Your Supervisor will hand over to you bundles of birth slips taluk-war in each district, split up into separate bundles for rural and urban. The slips relating to still-births and multiple births by taluks have been separated and will be given to you. These slips should be kept separately. First take up the single birth slips relating to a rural area in a taluk. The slips should be sorted into the following three economic groups:

- (a) Agricultural landholders and tenants (Livelihood Classes I, II and IV).
- (b) Agricultural labourers (Livelihood Class VI).
- (c) Non-agricultural Classes (Livelihood Classes V to VIII).

Against question 1(c) in each slip the Livelihood Class concerned has been noted already. The slips should therefore be sorted in 3 pigeon-holes for the 3 groups mentioned above. The total number of slips in each group should be counted and that number together with the number of multiple births in each economic group should be entered in the relevant columns, viz., 7, 8 or 9 of the Sorter's ticket, as the case may be. The total of columns 7 to 9 should be entered in column 6. The number of slips in each economic group together with the number of slips relating to the multiple births under each economic group should be entered in columns 3, 4 and 5. The totals of columns 3, 4 and 5 should be entered in column 2. The slips under each economic group should then be sorted into male births and female births with reference to the answer to question 6. To the total number of male birth slips and female birth slips should be added the number of multiple births for that group which are kept separately and the totals for each group should be entered in the relevant columns 11 to 13 and 15 to 17 according as they relate to males or females. The slips relating to males for all three economic groups should then be combined and then sorted for columns 18, 20 and 22. The slips relating to females for the three economic groups should then be combined and sorted for columns 19, 21 and 23. The totals of columns 11 to 13 and 15 to 17 should be entered in columns 10 and 14, respectively.

Repeat the process for urban. Add up the total for the taluk. Afterwards add up the total for the district separately for rural, urban and grand district total. After your Supervisor has checked, the slips for the economic groups should be combined for each taluk and there should be only two bundles one relating to rural and the other to urban.

NOTE: The total number of still-births in each taluk and for the ~~district~~ district under each of the three economic groups should be counted and given in fly-leaf to Table V.

\*Note the difference between 'the number of multiple births' and 'the number of slips relating to multiple births'.

INSTRUCTIONS

NUMBER OF CHILDREN BORN AND SURVIVING TO MOTHERS IN SAMPLE HOUSE-  
HOLDS BY ORDER OF BIRTHS AND PRESENT AGE OF MOTHER.

Take the bundle relating to rural areas. The slips should be sorted into the following 6 age groups with reference to the age given in answer to question 7 of the birth slip:

- 14 and less,
- 15 to 24,
- 25 to 34,
- 35 to 44,
- 45 and over, and
- Age not stated.

Count the number of slips in each of these age groups and enter the numbers in columns, 3, 6, 9, 12, 15, 18 and 21, respectively of the Sorter's ticket, against the heading 'Total number of mothers' in column 1 of the Sorter's ticket. Then take the slips in the age group 14 and less and sort them with reference to the answer to question 8 into number of mothers who have born one child, 2 children, 3 children, 4 children, 5 children, 6 children and 7 or more children. Count the slips in each of these categories and enter the numbers in column 6 against the respective headings in column 1 of the Sorter's ticket. The total number of children born to each category of mothers should then be ascertained by adding up the total against question 8 in each slip in the age group and written in column 6 against respective headings in column 1 of the ticket. In each case it should then be ascertained with reference to the answer to question No. 8(a)(i) and (ii), the total number of children surviving at present in all the slips in the age group and this number should be written in column 6 against the respective headings. The total number of children who have died should then be ascertained from the answer to question No. 8(b) and the total of the numbers in each category of mothers should be written in column 6 against the respective headings in column 1 of the Sorter's ticket. The usual additions to the relevant columns should be made for multiple births ~~were~~/had been earlier /which taken out. Repeat the process for every age group in the Sorter's ticket and enter the figures in columns 9, 12, 15, 18 and 21 respectively.

Then take the bundle for urban areas and repeat the operation and enter the figures in the respective columns relating to urban, namely, 7, 10, 13, 16, 19 and 22. Add up the numbers against the relevant headings in each column and fill up the totals at the end of the Sorter's ticket.

The rural and urban totals in all the ~~each~~/groups should /age be entered in the totals column in each age group. The totals of all figures relating to rural in the various age groups should be entered in column 3 and of the urban in column 4. The totals of columns 3 and 4 should be entered in column 2.

NOTE: The fly-leaf should state how many multiple births there were by age of mother.

Your Supervisor will hand over to you bundles of death slips taluk-war in each district, split up into separate bundles for rural and urban. The slips should be sorted into the following three economic groups:

- (a) Agricultural land holders and tenants (Livelihood Classes I, II & IV),
- (b) Agricultural labourers (Livelihood Class III),
- (c) Non-Agricultural Classes (Livelihood Classes V to VIII).

Against question 1(c) in each slip the Livelihood Class concerned has been noted already. The slips should therefore be sorted in 3 pigeon-holes for the 3 groups mentioned above. The total number of slips in each group should be entered in the relevant columns, viz., 3,4 or 5 of the Sorter's ticket, as the case may be. The total of columns 3 to 5 should be entered in column 2. The slips under each economic group should then be sorted into male deaths and female deaths with reference to the answer to question 6. The totals for each group should be entered in the relevant columns 7 to 9 and 11 to 13 according as they relate to males and females. The slips relating to males for all three economic groups should then be combined and then sorted for columns 14, 16 and 18. The slips relating to females for the three economic groups should then be combined and sorted for columns 15, 17 and 19. Bundle up the slips relating to each of these columns separately. The totals of columns 7 to 9 and 11 to 13 should be entered in columns 6 and 10, respectively.

Repeat the process for urban.

Add up the total for the taluk. Afterwards add up the total for the district separately for rural, urban and grand district total. After your Supervisor has checked, there should be six bundles for the rural areas and six for urban.

INSTRUCTIONS.

NUMBER OF DEATHS IN SAMPLE HOUSEHOLDS BY SEX AND AGE OF DEATH:

After completing Sorter's ticket 7, take the bundle relating to registered male deaths. Sort these slips with reference to question No. 5 of the slip into age groups given in the Sorter's ticket and the total number should be entered in the respective columns of the ~~xxx~~ ticket relating to males. Similarly the slips relating to registered female deaths should be sorted by age groups given in the Sorter's ticket and the numbers entered in the respective columns of the ticket relating to females. This ticket should be marked 8-A. Repeat the process for the slips relating to unregistered male and female deaths and fill up the columns of another sorter's ticket which should be marked 8-B. Similarly sort also for the slips in which the answer to question 9 has been ~~xxxxxxxx~~ 'unknwn' and mark the Sorter's ticket 8-C.

Repeat the process for urban.

Add up the totals for the taluk. Afterwards add up the totals for the district separately for rural, urban and grand district total. Then, from these 3 sorter's tickets, another sorter's ticket should be prepared for the entire death slips which is Sorter's ticket 8. The columns in this Sorter's ticket should be filled up by adding up the corresponding columns in the other 3 Sorter's tickets, 8-A, 8-B and 8-C.
