Tender Notice for purchase of 64 numbers of Batteries as per specifications and other relevant particulars shown as under:-

Capacity : 65 AH AMRON QUANTA/YUASA GLOBAL ROCKET.
Quantity : 64 numbers of Batteries.
Connectivity : 65 AH Batteries, Volts - 12, Type – SMF.
Comprehensive : Minimum two years warranty.
Delivery : Directorate of Census Operations, U.T., Plot No. 2-B,
Sector 19-A, Chandigarh.

Terms & Conditions:-

1. The sealed tender should be clearly super scribed as Tender for Batteries. It should be (i) Technical Bid (ii) Price Bid.
2. The Tender shall be valid till the final letter or communication is received from the Department.
3. The sealed envelope should contain the rates quoted by the firm and shall be super scribed “Tender for procurement of Batteries”.
4. The Tender must be accompanied by earnest money of Rs. 10,000/- (Rs. Ten Thousand Only) in the shape of Bank Draft/Pay Order of any Scheduled Bank drawn in favour of Assistant Director, Census Operations, U.T., Chandigarh which should be valid for a period of minimum of six months.

The same will be returned to the unsuccessful tenderers soon after the order is placed. The amount of earnest money shall not be accepted through cheque. The earnest money of the successful tenderer shall be converted into performance security, if desired, and shall be refunded after the faithful execution/completion of the contract without any interest.

5. No tender without earnest money deposit will be entertained. Price quoted should include all charges like VAT, duty, insurance, technical service etc. with at least three years on site comprehensive warranty from the date of supply and acceptance of the item at site. No other charges/taxes/levied will be paid by the department during pendency of the contract/supply.
6. The tenderer should have experience of 2 years ending 31.3.2015 having successfully completed work of similar nature during the last two years.
7. Sealed tender completed in all respects should reach on or before 13.7.2015 at 3.00 PM and should be addressed in the name of Assistant Director, Census Operations, U.T., Plot No. 2-B, Sector 19-A, Chandigarh – 160019. The Technical Bid will be opened at 3.30 PM on 13.7.2015 in the presence of the representatives of the tenderers if any. The price bids of tenderers, who will be found valid in documentation of Technical Bid, will only be opened on 13.7.2015 at 4.30 PM. Incomplete tenders or those without earnest money will be rejected. Tenders after due date and time will not be accepted.
8. The successful tenderer will have to deposit Performance Security of Rs. 20,000/- by Demand Draft in favour of Assistant Director, Census Operations, U.T., Chandigarh which will be refunded after the supply is received by the department satisfactorily. The supplier will request the return of Performance Security. In case the successful tender desires, the amount of Rs. 10,000/- as Earnest Money can also be got adjusted with that of Performance Security i.e. the Demand Draft of Rs. 10,000/- more will be required in addition to the EMD.

9. The material so supplied will be inspected by an Inspection Committee comprising of the officers of this Organization. In case, the supply is not found in conformity with the approved specifications, the same will be liable to be rejected & will be required to be replaced with supply exactly commensurate with approved specifications and may also impose reasonable penalty for deficiency in service. The decision of the Department will be final, unassailable & binding on the supplier.
10. Delivery & installation period should be mentioned in the tender which should not exceed 10 days, penalty for the late delivery would be levied at the rate of 2% per week subject to maximum of 10% of the value of the material not supplied within the stipulated period. In case delivery is not completed within the specific delivery period, the department is authorized to cancel and arrange the said item from any other source at the risk & cost of tenderer.
11. The department reserves the right to accept or reject any or all the tenderers without assigning any reasons.
12. The payment will be made after the complete supply and installation is made as per approved specifications without payment of any advance payment.
13. The department reserves the right to revise or alter the requirement and/or specifications of the material before acceptance of any tender at any time and call for revised tenders.
14. Overwriting/overtyping or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the tender invalid.
15. Ambiguous rate or rates not in conformity & specifications as mentioned above or conditional and/or without inclusion of all taxes/charges as on date shall be rejected.
16. The department shall be at liberty to test the material from any sources for satisfaction. The sample or testing shall be provided by the contractor. In case the sample of particular lot fails in testing, the supplier shall be bound to replace the entire lot with free material of prescribed specification. The

- rejected lot shall be returned to the supplier only after the fresh lot is supplied. Testing charges in respect of failed sample will be borne by the contractor/supplier.
17. In case of any dispute regarding rejection of quantity and quality of material, the decision of the Department shall be final and binding on the contractor/supplier.
 18. The supplier shall himself arrange for material required by him, no recommendation letter shall be issued by the department/office.
 19. The department does not pledge himself to accept the lowest or any tender and reserves to himself the right of acceptance or whole or any part of tender or portion of quantity offered and the supplier shall supply the same at the rates quoted.
 20. The supply shall be made at the office of Census Operations (Ground Floor), Plot No. 2-B, Sector 19-A, Chandigarh – 160019 and nothing extra shall be paid by way of carriage or any other charges.
 21. Before making the supply, the contractor shall be required to get the sample approved by the Department or the Authorized Officers.
 22. Any damage due to handling in transit shall be borne by the contractor and nothing shall be paid extra for handling.
 23. No sketch or design shall be supplied by the department.
 24. The quantity is tentative and can be increased or decreased at the will of the department.
 25. The Income Tax Returns for the last two Assessment years (2014-15 & 2015-16) must be enclosed with the Technical Bids.


