Interested registered firms/dealers/agencies/distributors of Battery may quote their lowest rates for supply and highest rate for purchasing earlier batteries showing the actual price and taxes in details which will be deducted at source. Quotations in sealed cover with superscription "Quotation for supply of Battery for UPS" should be submitted to Shri M.R.V.KRISHNA RAO, Joint Director, office of the DCO, Tamilnadu before 3 p.m. of 10th April.2015 through Post/Courier/By Hand and the same will be opened at 4 p.m. on 10th April.2015 (same day) by the Chairman in the above office premises in the presence of all available bidders and Members of Purchase Committee. The Competitors or their authorized representatives may attend if they so desire during the opening of their quotations on the date and time mentioned above.

Terms & Conditions of the contract will be as follows:-

1. Interested firms may visit and verify former batteries during office hours.
2. The Firm will have to supply at their own arrangement during office hours.
3. Buy-back value to be deducted from the cost of new Battery Bank.
4. Batteries comprehensive: Minimum 03(three) years warranty.

An Earnest Money Deposit of Rs.15,000/- (Rupees fifteen thousand) only must be deposited alongwith the quotation in the form of Banker Cheque from any National Banks/ Bank Draft in favour of 'Drawing and Disbursing Officer,D.C.O Tamilnadu ,payable at Chennai.

6. Firm will have to submit a copy of VAT Clearance Certificate upto date, a copy of trade License/Registration Certificate of the firm and a copy of the performance Certificate from concerned Deptt. Alongwith tender documents.

7. Rates should be inclusive of all kinds of taxes, etc. Whatsoever and Directorate will not pay any claims of the firm in this respect. Taxes will be deducted at source (TDS) from bills as per prevailing rules. A copy of VAT Registration and Clearance Certificate should also be enclosed.

8. The payment will be made-only after successful completion of the job and after due verification.

9. The materials to be used must be of required quality and specification and if the materials supplied do not conform to the specified quality, the same will be rejected and the cost of which will bear by the firm.

10. All the pages of the tender document should be signed with stamp by the authorized signatory before submitting.

11. Tender document should be sealed.

12. Firms are also advised not to erase or mutilate the figures etc. otherwise the quotation may be ignored. Any overwriting will not be allowed.



16. In case of any dispute the decision of this Directorate shall be final.


