
This office proposes to purchase 13 Nos. (approx) Servers of reputed brand like HP, Dell, Lenovo etc. of suitable specification for Directorate of census Operations located at State Capitals. The detail specifications of the Servers are enclosed at Annexure 'A'.

2. Intending firms, who will be in a position to supply and install the above mentioned item at Directorate of Census Operations, may submit their sealed quotations, containing their best rates **(in the attached profoma Annexure 'B')** along with an **EMD of Rs. 65,000/-** in form of Demand Draft or Pay Order drawn in any nationalized Bank in favour of **"Pay and Accounts Officer (Census), New Delhi"** Failure of the selected firm to comply with the requirement/ Job Order will lead to forfeiture of the EMD.

3. Other terms and conditions are as given below:-

- a) Sealed Quotations along with sample should reach the undersigned latest by **3:00 PM of 03.03.2015**. Quotations received after the specified date/ time shall not be entertained.
- b) Quotations shall be opened on the same day at **3:30 PM** in presence of the firms or their representatives, if any.
- c) **The firm should submit the tender specific authorization letter from OEM.**
- d) The details of maximum days of delivery & installation should be mentioned in the quotations.
- e) **Quoted rate should be valid for minimum period of six months.**
- f) A copy of latest Sales Tax/ VAT clearance certificate duly self-attested should be submitted along with the quotation.
- g) Each and every page of the tender document should be stamped and ink signed.
- h) Bank charges, if any shall be borne by the successful tenderer.
- i) The material should be properly delivered in conformity with the specification to the satisfaction of the concerned authority.
- j) This office reserves the right to reject any or all without assigning any reason therefore.
- k) Performance Security: the successful bidder with the job shall be required to deposit Performance Security equivalent to 10 % of the total value of the work order rounded up to next hundred, in the form of Account payee demand Draft/ Bank Guarantee from a Nationalized/ Scheduled Commercial Bank in favour of "Pay & Accounts Officer (Census)" payable at New Delhi. If the Security deposit is not deposited within time specified, the Earnest Money Deposit of the bidder shall be forfeited.
- l) The successful bidder should be in position to supply and install the above item within 15 days from the date of issue of the work order.
