The interested parties may submit their tender in sealed covers at the Directorate of Census Operation, Delhi C-Wing, Ground floor, Pushpa Bhawan, New Delhi along with an earnest money or Rs. 5000/- (Rupees five Thousand Only) in the form of Demand Draft/Pay Order from any nationalized bank drawn in favour of the **Director of Census Operations, Delhi** latest by 3 P.M On 05-02-2015. The tender shall be opened on the same day at 3:30 P.M. in the presence of tenderers or their authorized representatives, if any. The tenders received after stipulated date and time shall not be entertained. The tender received without earnest money in the form of demand draft/pay order shall also be summarily rejected without assigning any reason.

Other terms and conditions are given below:-

1. Obsolete/unserviceable store item included in Annexure I may be inspected on any working day during working hours at Block – 8, Old Sectt, & Pushpa Bhawan C-Wing, Ground floor, Madangir Road, New Delhi indicated in Annexure - I. The tenderers can meet the Sh. Bal Krishan, A.D. Admin, Directorate of Census Operations, Delhi, Pushpa Bhawan, C-Wing, Ground floor, New Delhi.
2. The firms offering highest purchase value for all the items will be declared as successful for the tender.
3. Full payment after adjustment of EMD will have to be made by the successful tenderer(s) within two working days in the form of Demand Draft/Pay Order drawn in favour of the **Director of Census Operations, Delhi** from the offer date and arrange to lift the obsolete/unserviceable store items from this office within next two days failing which the offer will stand cancelled and earnest money would be forfeited.
4. In case of the failure of the highest bidder to lift the item as per the conditions laid down at (3) above, opportunity shall be given to the next bidders with the same conditions.
5. EMD of the unsuccessful bidders shall be returned within 30 days.
