Terms & Conditions of the contract will be as follows:-

1. The firm will have to work in consultation with the Directorate.

4. The rate should be inclusion of all kinds of Taxes, etc. whatsoever and Directorate will not pay any claims of the firm in this respect. Taxes will be deducted at source (TDS) from bills as per prevailing rates.

5. Firm have to submit a copy of VAT Clearance Certificate upto date, a copy of Trade License/ Registration Certificate of the firm and a copy of the performance Certificate from concerned Deptt. alongwith tender documents. A copy of the PAN card of the proprietor of the firm.
6. After prepared the board, firm will supply and install the item in the space allotted by this office at their own arrangement during office hours.
7. The payment will be made only after successful completion of the job and after due verification.
8. The equipments to be used must be of required quality and specification and if the equipments do not conform to the specified quality, the same will be rejected and the cost of which will be borne by the firm.


