Quotation in sealed cover along with the earnest money of Rs.5,000/- in the form of Account Payee Demand Draft/Pay Order of any Nationalized/Scheduled Bank drawn in favour of "Pay & Accounts Officer (Census)" payable at "New Delhi". The quotation may be submitted on or before 14.09.2017 by 3.30 P. M. The quotations not accompanied by EMD will not be entertained. The quotations will be opened in this office at 4.30 P. M. on the same day in the presence of bidders or their representatives who wish to be present. The bidder, quoting the highest price, will be eligible for getting the vehicle. Full payment will have to be made by the successful bidder within 07 working days and he/she will have arrange to lift vehicle within next 07 working days, failing which the offer will stand cancelled and earnest money would be forfeited. The terms & conditions for the participating bidders are as under:

- (1) The bidders should have valid Photo Identity proof, PAN Card, Aadhar Number, etc.
- (2) The bidders should have own bank account of any nationalized bank.
- (3) In case of bid submitted by any firm, they should have GST registration number and attach the copy of the same.
- (4) The vehicle will be handed over / transferred to the highest bidder and the cost involved in lifting of vehicle and transfer will be borne by the bidder.
- (5) The rate quoted by the highest bidder must be more than the reserve price as given by Airport Authority of India which is in sealed cover and will be opened after opening of bids of bidders.
- (6) The rate quoted by the highest bidder will also be compared with assessment of Maruti True Value. If the rate quoted by Maruti True Value is more than that of the highest bidder, the vehicle may be transferred to the Maruti True Value, otherwise to the highest bidder.
