- i. The following new clause under para E (Penalty) at Page No.82-83 is to be added
“f. The overall penalty imposed on SI-S should not exceed to the 10% of overall project value.”
- j. The following new clause under para D(Clarification on Payment) at Page No.81-82 is to be added
“o. ORGI will strive to clear all the invoices within thirty days after receipt of clear/verified invoices duly signed by concerned authority of ORGI/DCO.”
