The Quotation are to be reached to the Directorate of Census Operations, West Bengal, Janganana Bhawan, IB-199Sector-III, Salt Lake city, Kolkata-700106 on or before 30.03.2023upto 4.00 p.m..An A/c Payee Demand Draft 5% of the Tender Value in favour of "Directorate of Census Operations, West Bengal" as Bid Security should be attached with the quotation which will be returned in due course without interest to unsuccessful bidders and will be retained for successful bidder as performance securitywhich will be refunded after successful and satisfactory completion of the work. The transporter/bidder must have relevant papers in support of being a Registered transporters. If any successful Bidders denies supply as per their offered rate, Earnest Money Deposit (EMD) will be forfeited and action will be taken as Government of India Rules and Regulations. - 1. The work to be executed between 9.00A.M. to 5.00P.M.
- 2. 80 nos. of steel racks are to be dismantled at Badu Godown and after carrying the same, these are to be installed with rack shoe at the respective floors of DCO, West Bengal, Salt Lake, along with materials.
- 3. This work/rates will remain valid for one year w.e.f. the date of acceptance of the offer and no enhancement of any charges in interim period will be entertained.
- 4. Sealed quotation are to be submitted in the office of the undersigned on all working days upto 4.00 P.M. on 30.03.2023.
- 5. The quotation shall be opened on 30.03.2023 at 4.30 P.M. before the Tender Committee, Directorate of Census Operations, West Bengal where all the vendors or their representatives may kindly make it convenient to be present.
- 6. The DCO, West Bengal reserves the right to accept or reject any quotation on any ground or without assigning any reasons whatsoever. Representative of the willing bidders are permitted to carrying necessary inspection at West Bengal State Warehousing Corporation , P.O.- Badu, Baristar Bagan, Madhyamgram, North 24 Parganas, West Bengal - 700128 during office hours on working days for their assessing the volume of amount to be transported.
- 7. No detention charges should be entertained for the entire period of shifting.
- 8. The bidder is responsible for any damage caused to the material/government property by him/her/it or his/her/its workers at the time of loading/unloading.
- 9. The bidder should quote price in Indian Currency only. The offered price must include all the services to be performed at dispatching point, during transportation and at the receiving points as indicated and all taxes etc.
- 10. Consortium or Sub Contract is strictly prohibited.
- 11. Safe and timely transportation of the Census documents by road from West Bengal State Warehousing Corporation, P.O.-Badu, Baristar Bagan, Madhyamgram, North 24 Parganas, West Bengal - 700128to Directorate of Census Operations, West Bengal, IB-199, Sector - III, Salt Lake, Kolkata - 700106. Any other taxes en-route shall be borne by the contractor.
- 12. The workers deployed by the bidder/service provider shall be workers of the bidder/service provider for all purposes and the department shall have no relation / responsibility in respect of workers on any matter.
- 13. The successful bidder should comply with all statutory obligations.

In case of any breakdown of any truck etc. during duty it should be the responsibility of the /bidder transporter to provide a substitute vehicle, which is of similar make as replacement immediately along with loading and unloading charges maintaining safety and security of the Government documents.
- 15. The vehicle should fulfill the legal obligation prescribed by the State Transport Department. All requirement under various statutory laws must be compiled with. Any default will be the liability of the bidder and this Department shall not be liable in any matter whatsoever, in case of any accident or any contingency and claim arising out from such incident, it shall be borne by the bidder and no claim whatsoever shall be borne by the Directorate of Census Operations, WB.
